- Cancellation of an exam result
- Revocation of a certification title and ability to use NetSuite logos
- Requirement or retesting to maintain a certification title
- Ban test-taker from NetSuite Certification program

## II. Usage of Logo and other Designations:

Logos are permitted to be used only in the following ways and solely by certified individuals (not by company or organizations):

- On printed business cards for an individual
- As part of email signatures of certified individuals
- Displayed on social media sites on an individual profile
- On resumes for an individual
- On an individual's listing within a company website

Certification logos are **not** permitted to be used in the following ways:

- On any company sales and marketing materials/websites to describe the company as being certified
- On social media profiles for companies or organizations, unless prior written permission provided by certification@netsuite.com
- On company letterhead



What individuals may state verbatim:

- “I have passed the NetSuite “[insert exam name]” exam.”
- “I am a NetSuite Certified (insert certification title).”

What companies or organizations may state verbatim, instead of using a logo:

- “We have [X number] NetSuite Certified (insert certification title).”

Usage restrictions related to design:

- The logo must be used in its entirety, as provided, with no changes to color, font, or missing parts of the design
- No modification of the logo, other than size, is permitted
- New logos derived from these NetSuite Certification logos may not be created
- Translation of text in the logo is not permitted
- Multiple logos may not be combined into one logo
- The name of the certified individual must always accompany the use of the logo
- The logo and the name of the certified individual should be equally prominent

Additional requirements for logo usage:

The NetSuite corporate logo is the most significant visual representation of our company. The NetSuite logo features two elements—our logotype and the interlocking N graphic. They are designed to optimize the relationship between each element. The N graphic is represented in blue (PMS 541) and blue gray (PMS 5435). The logotype is represented in black. Always treat the corporate logo as one unit; it should never be divided or modified. In addition, display the corporate logo away from other elements, such as images or other logos. The horizontal configuration of the logo is our primary identifier. Apply the vertical logo only when horizontal space is limited. Except as specifically provided by the Certification team, all instances using the vertical logo require approval from NetSuite (email [certification@netsuite.com](mailto:certification@netsuite.com)).

The three-color logo on a white background is the most preferred application. It can be reproduced using spot colors (PMS), the four color process (CMYK) and web-safe colors (RGB) for online applications. In situations where colors are not available, display the N graphic and logotype all in black. When placing the logo against a dark background, always reverse out the logo to white. Except as specifically provided by the Certification team, all instances using the one-color black logo or one-color reverse (white on dark) logo require approval from NetSuite (email [certification@netsuite.com](mailto:certification@netsuite.com)).
